SUMMARY ORDER OF REVOCATION

Pursuant to K.S.A. 77-537

The above-captioned matter comes on for Commission action through a summary proceeding under the Kansas Administrative Procedures Act, K.S.A. 77-537, regarding the law enforcement certification of JOHNNY YELVERTON (Respondent).

STATEMENT OF FACTS

1. Respondent holds a full-time law enforcement certification from the Kansas Commission on Peace Officers' Standards and Training (Commission), certification number 19869.

2. Respondent was not employed as a law enforcement officer at the time of his felony conduct.

3. On March 1, 2018 and April 28, 2018, Respondent unlawfully engaged in consensual sexual intercourse, lewd fondling or touching, or sodomy with a person who was seventeen years of age. At the time, Respondent was a teacher or person in a position of authority at a school offering grades

kindergarten through grade twelve and the victim was enrolled as a student. Respondent and the victim were not married.

4. Respondent was charged and convicted in the District Court of Kansas Eighteenth Judicial District, in Case Number 18CR1254, with two counts of Unlawful Sexual Relations, contrary to K.S.A. 21-5512(a)(9), a severity level 5 person felony.

CONCLUSIONS OF LAW

Felony Conviction

5. Pursuant to K.S.A. 74-5616(b)(1) the Commission may revoke the certification of a police or law enforcement officer who fails to meet and maintain the requirements of K.S.A. 74-5605 or 74-5607a, and amendments thereto.
6. K.S.A. 74-5605(b)(3) states that each applicant for certification shall not have been convicted of a crime that would constitute a felony under the laws of this state.
7. Due to his felony convictions in Eighteenth Judicial District Court Case Number 18CR1254, Respondent fails to meet and maintain the requirements of K.S.A. 74-5605.

Good Moral Character

8. Pursuant to K.S.A. 74-5616(b)(1) the Commission may revoke the certification of a police or law enforcement officer who fails to meet and maintain the requirements of K.S.A. 74-5605 or 74-5607a, and amendments thereto.
9. K.S.A. 74-5605(b)(5) states that each applicant for certification shall be of good moral character sufficient to warrant the public trust in the applicant as a police officer or law enforcement officer.

10. K.A.R. 106-2-4(a) defines good moral character as including the personal traits or qualities of integrity, honesty, upholding the laws of the state and nation, conduct that warrants the public trust, and upholding the oath required for certification as specified in K.A.R. 106-3-6.

11. Respondent's conduct resulting in his felony convictions in Eighteenth Judicial District Court Case Number 18CR1254 shows that he lacks the personal qualities of integrity, honesty, upholding the laws of the state, conduct that warrants the public trust, and upholding the oath required for certification.

Summary Proceedings

12. Under K.S.A. 77-537, the Commission may conduct these summary proceedings, subject to Respondent's request for a hearing. The Commission finds that the use of summary proceedings in these circumstances does not violate any provisions of law and the protection of the public interest does not require the Commission to give notice and opportunity to participate to any person other than Respondent.

ORDER

Based on these Statement of Facts and Conclusions of Law, the Commission orders that the Kansas Law Enforcement Officer Certification of JOHNNY YELVERTON be revoked.

ACCORDINGLY, THE KANSAS COMMISSION ON PEACE OFFICERS' STANDARDS AND TRAINING CERTIFICATE OF JOHNNY YELVERTON IS HEREBY REVOKED.

FURTHER, Respondent is ordered to surrender and return to the Commission all evidence of his certification as a law enforcement officer.

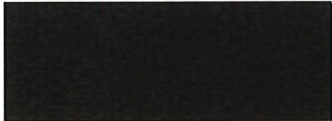
NOTICE OF RELIEF FROM THIS SUMMARY ORDER
