**SUMMARY ORDER OF REPRIMAND**

Pursuant to K.S.A. 77-537

The above-captioned matter comes on for action by the Kansas Commission on Peace Officers' Standards and Training (Commission) through a summary proceeding under the Kansas Administrative Procedures Act, K.S.A. 77-537, *et seq.*, regarding the law enforcement certification of GLENN ANDERSON (Respondent).

**STATEMENT OF FACTS**

1. Respondent holds a certification from the Commission, certification number 301.
2. Respondent has been employed as the Sheriff of the Scott County Sheriff's Office (SCSO) from August 11, 2003, to present.
3. In May 2017, Respondent submitted a Demographic and Employment Information form (Demographic) to the Commission. The Demographic was submitted pursuant to K.S.A. 74-5611a and K.S.A. 74-5605, and indicated that Jade Daniels (Daniels) had been hired as a law enforcement officer for the SCSO in January 2017. Respondent signed the Demographic directly below language stating, "By signing below, I swear under penalty of perjury that the

information contained in this form is true, correct and complete to the best of my knowledge, and the applicant satisfies all of the requirements to be a law enforcement officer as provided in K.S.A. 74-5605.”

4. The Demographic indicated a starting date of employment as a law enforcement officer for Daniels that was prior to the signature dates completed by both Daniels and Respondent. The Demographic was returned to Respondent, with an indication that it could not be processed due to deficiencies, and explicitly stating, “The Oath of Honor must be signed on or before the officer’s active date of employment per KAR 106-3-6. Officer also must be verified to meet the minimum requirements to be provisionally certified as a law enforcement officer on or before his active date of employment per KSA 74-5605(b).”
5. The Demographic also prompted questions about whether the information provided therein was sufficient to establish that Daniels met the certification requirement of high school graduation or the equivalent, pursuant to K.S.A. 74-5605(b)(4) and K.A.R. 106-3-4.
6. Respondent eventually provided proof of high school equivalency for Daniels and submitted a form with corrected dates. The corrected form contained the same language as the previously submitted Demographic, indicating that Daniels “satisfies all of the requirements to be a law enforcement officer as provided by K.S.A. 74-5605.” The Demographic was signed by Respondent. However, at the time the Demographic was submitted by Respondent, Daniels did not meet all the requirements to be a law enforcement officer pursuant to K.S.A. 74-5605.
7. Pursuant to K.S.A. 74-5605(b)(1), Each applicant for certification shall be a United States Citizen. At the time Respondent submitted the Demographic to the Commission, Daniels was not a United States citizen, but was a Permanent Resident. Daniels became a United States citizen on October 8, 2020.
8. Based on Respondent’s affirmations regarding Daniels on the Demographic and the submission of the Demographic to the Commission, the Commission

issued a provisional law enforcement certification to Daniels. Once Daniels successfully completed basic academy, the Commission issued a full-time law enforcement certification to Daniels.

#### CONCLUSIONS OF LAW

9. Pursuant to K.S.A. 74-5616(b)(2), the Commission may suspend, condition, or revoke the certification of a police officer or law enforcement officer, reprimand or censure a police or law enforcement officer, or deny the certification of a police officer or law enforcement officer who has knowingly submitted false or misleading documents or willfully failed to obtain any certification under the Kansas Law Enforcement Training Act.
10. Respondent submitted false or misleading documents to the Commission. Daniels was not a United States citizen at the time he was hired by the SCSO as a law enforcement officer. Respondent signed and submitted the Demographic to the Commission indicating that Daniels met the requirements for certification, which includes United States citizenship.
11. Under K.S.A. 77-537, the Commission may conduct these summary proceedings, subject to respondent's request for a hearing. The Commission finds that the use of summary proceedings in these circumstances does not violate any provisions of law and the protection of the public interest does not require the Commission to give notice and opportunity to participate to any person other than Respondent.


**ORDER**

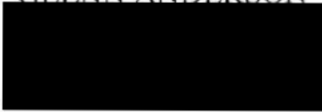
**NOTICE OF RELIEF FROM THIS SUMMARY ORDER**
