# SUMMARY ORDER OF REVOCATION

Pursuant to K.S.A. 77-537

The above-captioned matter comes on for Commission action through a summary proceeding under the Kansas Administrative Procedures Act, K.S.A. 77-537, regarding the law enforcement certification of TATE ROSENBAUM (Respondent).

#### STATEMENT OF FACTS

- 1. The Kansas Commission on Peace Officers' Standards and Training (Commission) granted full-time certification to Respondent on January 15, 2016, certification number 28722.
- 2. Respondent began full-time employment with the Medicine Lodge Police Department on January 19, 2021.
- 3. On July 22, 2021, Respondent's twelve-year-old son had a physical conflict with another family member and left the house on foot. Respondent got in his vehicle and drove to find his son. Once he was located, Respondent grabbed his son and put him against the vehicle. Respondent held his son against the vehicle and picked him up by grabbing his upper body

by the head and shoulders. Respondent lifted his son off the ground and threw him into the passenger side of the vehicle. Respondent was "very mad" at the time and caused visible injury to his son.

- 4. Respondent was criminally charged in the District Court of Pratt County, Case Number 2021-CR-98, with one count of abuse of a child and one count of battery. On March 30, 2022, Respondent entered a plea and was found guilty to one count of battery, contrary to K.S.A. 21-5413, classified as a domestic violence offense. Respondent was ordered to surrender his law enforcement credentials to the Commission.
- 5. The Commission previously investigated Respondent for allegations of excessive use of force as a law enforcement officer and domestic battery against his spouse. Both incidents were alleged to have occurred in 2018. The Commission Investigative Committee closed this investigation, Case Number 2019-0118, with no certification action on September 18, 2019.

#### CONCLUSIONS OF LAW

# Criminal Conduct

- 6. Pursuant to K.S.A. 74-5616(b)(5), the Commission may revoke the certification of any police or law enforcement officer who engages in conduct which, if charged as a crime, would constitute a felony crime under the laws of this state, a misdemeanor crime of domestic violence as defined in the Kansas Law Enforcement Training Act at the time the conduct occurred, or a misdemeanor crime that the Commission determines reflects on the honesty, trustworthiness, integrity or competence of the applicant as defined by rules and regulations of the Commission.
- 7. K.A.R. 106-2-2a(a)(6) states that, pursuant to K.S.A. 74-5616 and amendments thereto, an applicant or officer shall not engage in conduct, whether or not charged as a crime or resulting in a conviction, that would constitute battery, as defined in K.S.A. 21-5413, and amendments thereto.

8. Respondent's conduct constitutes a misdemeanor crime that the Commission determines reflects on the honesty, trustworthiness, integrity, or competence of the applicant as defined by rules and regulations of the Commission. Respondent's conduct constitutes battery.

### Good Moral Character

- 9. Pursuant to K.S.A. 74-5616(b)(1) the Commission may revoke the certification of a police or law enforcement officer who fails to meet and maintain the requirements of K.S.A. 74-5605 or 74-5607a, and amendments thereto.
- 10. K.S.A. 74-5605(b)(5) states that each applicant for certification shall be of good moral character sufficient to warrant the public trust in the applicant as a police officer or law enforcement officer.
- 11. K.A.R. 106-2-4(a) defines good moral character as including the personal traits or qualities of integrity, honesty, upholding the laws of the state and nation, conduct that warrants the public trust, and upholding the oath required for certification as specified in K.A.R. 106-3-6.
- 12. Pursuant to K.A.R. 106-2-4(b), any single incident or event may suffice to show that a licensee lacks or has failed to maintain good moral character.
- 13. Respondent's conduct shows that he lacks the personal qualities of integrity, upholding the laws of the state, conduct that warrants the public trust, and upholding the oath required for certification.

## **Summary Proceedings**

14. Under K.S.A. 77-537, the Commission may conduct these summary proceedings, subject to Respondent's request for a hearing. The Commission finds that the use of summary proceedings in these circumstances does not violate any provisions of law and the protection of the public interest does not require the Commission to give notice and opportunity to participate to any person other than Respondent.

#### **ORDER**

Based on the above Statement of Facts and Conclusions of Law, the Commission orders that the Kansas Law Enforcement Officer Certification of TATE ROSENBAUM be revoked.

ACCORDINGLY, THE KANSAS COMMISSION ON PEACE OFFICERS'
STANDARDS AND TRAINING CERTIFICATE OF TATE ROSENBAUM IS HEREBY
REVOKED.

FURTHER, Respondent is ordered to surrender and return to the Commission all evidence of his certification as a law enforcement officer.
