SUMMARY ORDER OF REVOCATION

Pursuant to K.S.A. 77-537

The above-captioned matter comes on for Kansas Commission on Peace Officers’ Standards and Training (Commission) action through a summary proceeding under the Kansas Administrative Procedures Act, K.S.A. 77-537, regarding the law enforcement certification of JOSHUA HAGEMAN (Respondent).

STATEMENT OF FACTS

1. The Commission issued Respondent a full-time law enforcement certification, certification number 29225.
2. Respondent was employed as a full-time law enforcement officer with the Wichita Police Department (WPD) from July 5, 2016, to February 1, 2020.
3. On January 29, 2020, a police report was made after MM told her coworker, who is the spouse of a WPD officer, that Respondent inappropriately touched her in 2012, when she was fifteen years old.

4. On July 16, 2012, MM, CM, and Lauren were drinking alcohol at the residence of MM's cousin. Respondent was at the house as well. At the end of the night, MM and CM fell asleep on separate couches in the basement. At the time, MM and CM were fifteen years old and Respondent was twenty years old.
5. MM woke up to Respondent kissing her on the lips. MM told Respondent to stop and that she had a boyfriend. After falling back asleep, MM woke up to Respondent kissing her on the neck with his hand down her pants rubbing her clitoris. MM "vaguely" remembered Respondent going over to CM on the other couch and it looking as if CM was making out with Respondent. MM told CM and Lauren what happened the next day. In 2019, MM saw Respondent at a bar. Later that night, she sent him a Facebook message letting him know that she had not forgotten what he had done to her.
6. On the same night, CM was asleep and woke up to Respondent kissing her on the mouth "pretty aggressively." When she woke up, she "freaked out" and Respondent left. CM contacted her boyfriend, and he calmed her down. CM later told Lauren about the incident.
7. Based on his conduct in paragraphs four through six, Respondent was criminally charged in the Eighteenth Judicial District Court, Sedgwick County, Case Number 2020-CR-1177-FE, with two counts of indecent liberties with a child. On June 23, 2023, Respondent entered a plea agreement and was convicted of one count of aggravated battery, a felony, and one count of misdemeanor battery, contrary to K.S.A. 21-5413.

CONCLUSIONS OF LAW

Fail to Maintain Minimum Requirements for Certification

8. Pursuant to K.S.A. 74-5616(b)(1) the Commission may revoke the certification of a police or law enforcement officer who fails to meet and maintain the requirements of K.S.A. 74-5605 or 74-5607a, and amendments thereto.

Felony Conviction

9. K.S.A. 74-5605(b)(3) states that each applicant for certification shall not have been convicted of a crime that would constitute a felony under the laws of this state, a misdemeanor crime of domestic violence or a misdemeanor offense that the Commission determines reflects on the honesty, trustworthiness, integrity or competence of the applicant as defined by rules and regulations of the Commission.
10. Due to his felony conviction, Respondent fails to meet and maintain the requirements of K.S.A. 74-5605.

Good Moral Character

11. K.S.A. 74-5605(b)(5) states that each applicant for certification shall be of good moral character sufficient to warrant the public trust in the applicant as a police officer or law enforcement officer.
12. K.A.R. 106-2-4(a) defines good moral character as including the personal traits or qualities of integrity, honesty, upholding the laws of the state and nation, conduct that warrants the public trust, and upholding the oath required for certification as specified in K.A.R. 106-3-6.

13. Pursuant to K.A.R. 106-2-4(b), any single incident or event may suffice to show that an applicant or licensee lacks or has failed to maintain good moral character.
14. Respondent's conduct shows that he has failed to maintain good moral character sufficient to warrant the public trust in him as a law enforcement officer.

Criminal Conduct

15. Pursuant to K.S.A. 74-5616(b)(5), the Commission may suspend, condition, or revoke the certification of any police officer or law enforcement officer, reprimand or censure a police officer or law enforcement officer, or deny the certification of a police officer or law enforcement officer who engages in conduct which, if charged as a crime, would constitute a felony crime under the laws of this state, a misdemeanor crime of domestic violence as defined in the Kansas Law Enforcement Training Act at the time the conduct occurred, or a misdemeanor crime that the Commission determines reflects on the honesty, trustworthiness, integrity or competence of the applicant as defined by rules and regulations of the Commission.
16. K.A.R. 106-2-2a(a)(6) states that, pursuant to K.S.A. 74-5616, and amendments thereto, an applicant or officer shall not engage in conduct, whether or not charged as a crime or resulting in a conviction, that would constitute battery, as defined in K.S.A. 21-5413, and amendments thereto.

Summary Proceedings

17. Under K.S.A. 77-537, the Commission may conduct these summary proceedings, subject to Respondent's request for a hearing. The Commission finds that the use of summary proceedings in these circumstances does not violate any provisions of law and the protection of the public interest does not require the Commission to give notice and opportunity to participate to any person other than Respondent.

ORDER


Based on these Statement of Facts and Conclusions of Law, the Commission orders that the Kansas Law Enforcement Officer Certification of JOSHUA HAGEMAN be revoked.

ACCORDINGLY, THE KANSAS COMMISSION ON PEACE OFFICERS' STANDARDS AND TRAINING CERTIFICATE OF JOSHUA HAGEMAN IS HEREBY REVOKED.

FURTHER, Respondent is ordered to surrender and return to the Commission all evidence of his certification as a law enforcement officer.

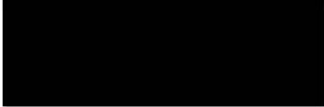
NOTICE OF RELIEF FROM THIS SUMMARY ORDER
