## **SUMMARY ORDER OF REVOCATION**

Pursuant to K.S.A. 77-537

The above-captioned matter comes on for Commission action through a summary proceeding under the Kansas Administrative Procedures Act, K.S.A. 77-537, regarding the law enforcement certification of LOUIS HEBERT (Respondent).

## STATEMENT OF FACTS

- 1. The Kansas Commission on Peace Officers' Standards and Training (Commission) granted full-time certification to Respondent, certification number 32133.
- Respondent was employed as a full-time law enforcement officer with the Wichita Police Department from August 10, 2020 to March 8, 2023.
- 3. On October 8, 2022, an officer with the Newton Police Department (NPD) observed Respondent driving his vehicle on the sidewalk after leaving a bar and conducted a traffic stop. Respondent admitted to consuming alcohol at the bar. The NPD officer asked Respondent to step out of the vehicle. Once Respondent was informed that a DUI

investigation was going to be conducted, he stated, "I am a Wichita Police Officer. I can show you my ID." The Intoxilyzer 9000 was administered to Respondent. The test result showed 0.118 BrAC. When informed that he was being arrested for DUI, Respondent stated, "Thaks for fucking up my career." Respondent was previously convicted of DUI in California.

4. Based on his conduct on October 8, 2022, Respondent was criminally charged and convicted in the City of Newton Municipal Court, Case Number 22N3264, with a second offense of driving under the influence. The elements of the municipal ordinance under which Respondent was charged are synonymous with K.S.A. 8-1567.

#### CONCLUSIONS OF LAW

### Criminal Conduct

- 5. Pursuant to K.S.A. 74-5616(b)(5), the Commission may revoke the certification of any police or law enforcement officer who engages in conduct which, if charged as a crime, would constitute a felony crime under the laws of this state, a misdemeanor crime of domestic violence as defined in the Kansas Law Enforcement Training Act at the time the conduct occurred, or a misdemeanor crime that the Commission determines reflects on the honesty, trustworthiness, integrity or competence of the applicant as defined by rules and regulations of the Commission.
- 6. K.A.R. 106-2-2a(a)(58) states that, pursuant to K.S.A. 74-5616, and amendments thereto, an applicant or officer shall not engage in conduct, whether or not charged as a crime or resulting in a conviction, that would constitute a second or subsequent occurrence of driving under the influence, as defined in K.S.A. 8-1567, and amendments thereto.
- 7. Respondent's conduct constitutes misdemeanor crimes that the Commission determines reflects on his honesty, trustworthiness, integrity, or competence as defined by rules and regulations of the Commission. Respondent's conduct constitutes a second or subsequent offense of driving under the influence.

#### Good Moral Character

- Pursuant to K.S.A. 74-5616(b)(1) the Commission may revoke the certification of a police or law enforcement officer who fails to meet and maintain the requirements of K.S.A. 74-5605 or 74-5607a, and amendments thereto.
- 9. K.S.A. 74-5605(b)(5) states that each applicant for certification shall be of good moral character sufficient to warrant the public trust in the applicant as a police officer or law enforcement officer.
- K.A.R. 106-2-4(a) defines good moral character as including the personal traits or qualities of integrity, honesty, upholding the laws of the state and nation, conduct that warrants the public trust, and upholding the oath required for certification as specified in K.A.R. 106-3-6.
- 11. Pursuant to K.A.R. 106-2-4(b), any single incident or event may suffice to show that a licensee lacks or has failed to maintain good moral character.
- 12. Respondent's conduct shows that he has failed to maintain good moral character sufficient to warrant the public trust in him as a law enforcement officer.

#### Summary Proceedings

13. Under K.S.A. 77-537, the Commission may conduct these summary proceedings, subject to Respondent's request for a hearing. The Commission finds that the use of summary proceedings in these circumstances does not violate any provisions of law and the protection of the public interest does not require the Commission to give notice and opportunity to participate to any person other than Respondent.

#### <u>ORDER</u>

Based on the above Statement of Facts and Conclusions of Law, the Commission orders that the Kansas Law Enforcement Officer Certification of LOUIS HEBERT be revoked.

ACCORDINGLY, THE KANSAS COMMISSION ON PEACE OFFICERS' STANDARDS AND TRAINING CERTIFICATE OF LOUIS HEBERT IS HEREBY REVOKED.

FURTHER, Respondent is ordered to surrender and return to the Commission all evidence of his certification as a law enforcement officer.
